

# **CFX Manager™ Software**

## ***End User License Agreement***

### ***PLEASE READ CAREFULLY***

**IMPORTANT!** The enclosed materials are provided to you on the express condition that you agree to this software license agreement. If you do not wish to accept the product under the below terms, you may return these materials to Bio-Rad Laboratories, in original packaging, within 3 days of receipt, for a refund.

Bio-Rad Laboratories hereby grants you, and you hereby accept, a non-exclusive license to use CFX Manager™ software and related materials (“Software”), provided in this package for operating Bio-Rad real-time PCR instruments and thermal cyclers and for data analysis. If you do not agree to the terms hereof, promptly return the Software with accompanying materials provided in and/or with this package to the place of purchase within 3 days of receipt for a refund.

Bio-Rad owns and retains all copyright, trade secret, patent and other proprietary rights, and all other right, title and interest, in and to the Software.

You may create a backup copy of the Software. You may not otherwise copy, reproduce or transmit any part of the Software in any form or by any means (including translation to another language, computer language or format). You may not reverse engineer, decompile, disassemble or otherwise reduce the Software to any human perceivable forms. You may not modify, adapt, translate, rent, lease, loan, resell for profit, transfer, export or create derivative works based upon the Software or any part thereof. You agree to keep confidential and use your best efforts to prevent unauthorized disclosure and use of, the contents of the Software.

Bio-Rad’s real-time thermal cyclers are licensed real-time thermal cyclers under Applera’s United States Patent 6,814,934 B1 for use in research, human in vitro diagnostics, and all other fields except veterinary diagnostics.

Subject to the terms and conditions herein, Bio-Rad warrants that the Software shall substantially conform, in all material respects, to Bio-Rad’s current specifications as published in Bio-Rad’s user and installation guides. CFX Manager software shall be installed freely for operating Bio-Rad instruments and data analysis purposes.

The Purchaser must notify Bio-Rad in writing, within thirty (30) days of delivery of the Software to the Purchaser (not including delivery of any subsequent modifications to the Software), of its claim of any defect. If the Software is found to be defective by Bio-Rad, Bio-Rad’s sole obligation under this warranty is to do one of the following: replace the defective Software, remedy such defect in a manner consistent with Bio-Rad’s regular business practices or refund the Software fees paid, in Bio-Rad’s sole discretion. If Bio-Rad chooses to remedy such defect, for a defect which materially adversely affects the performance of the Software, Bio-Rad shall use commercially reasonable efforts to cure such defect as soon as reasonably practicable after receipt of Purchaser’s notice, and for minor defects, Bio-Rad shall use commercially reasonable efforts to correct such minor defects in the next release of such software. If, however, Bio-Rad is unable to cure a major defect within (90) days of receipt of Purchaser’s notice, Purchaser shall have the option to cancel this Agreement whereupon Bio-Rad shall refund only the fees paid.
